### On Nevanlinna's proximity function. (\*\*)

#### 1. - Introduction.

Let  $f(z)$  be a meromorphic function in the entire complex plane  $C$ . Familiarity with the definitions of basic quantities of Nevalinna's theory of meromorphic functions:  $m(r, f)$ ,  $m(r, 1/f)$ ,  $n(r, f)$ ,  $n(r, 1/f)$ ,  $N(r, f)$ ,  $N(r, 1/f)$ ,  $T(r, f)$  etc. is assumed (see [2], [5]). We also write

$$m(r) = m(r, f) + m(r, 1/f)$$

and

$$N_p(r) = \int_0^r \frac{n(t)}{t^{p+1}} dt \quad (p = 0, 1, 2, 3, \dots),$$

where

$$n(r) = n(r, f) + n(r, 1/f)$$

and it is assumed, without any loss of generality, that  $n(r) = 0$ , for  $r \leq 1$ .

Our aim in this paper is to investigate the growth of  $m(r)$  with regard to  $n(r)$ ,  $N(r)$ ,  $N_p(r)$  and  $r^{\varrho(r)}$  where  $\varrho(r)$  is a proximate order of  $f(z)$ ,  $\varrho$  being the usual order of  $f(z)$  in terms of  $T(r, f)$ . Section 2 deals with the statement and discussion of the main results, whereas the remaining sections have been devoted to the proofs of the main results.

## 2. - Statement and discussion of results.

Recently in [3], Jain and Kamthan have proved, for a meromorphic function of order  $\rho$  ( $0 < \rho < 1$ ), that

$$(2.1) \quad \liminf_{r \rightarrow \infty} \frac{m(r)}{n(r)} \leq A(\rho),$$

where

$$(2.2) \quad A(\rho) = [\rho(1 - \rho)]^{-1} + 2(1 - \rho)^{-1} \cot \frac{1}{2} \pi \rho.$$

We prove here the following

**Theorem 1.** *Let  $f(z)$  be a meromorphic function of non-integral order  $\rho$ , ( $0 < \rho < \infty$ ). Then*

$$(2.3) \quad \liminf_{r \rightarrow \infty} \frac{m(r)}{n(r)} < \infty.$$

The above result is not necessarily true for functions of integral order. Consider for example (see [2], p. 7) the function  $f(z) = \exp [z]$ . Then  $m(r) = (2r/\pi)$  for all  $r > 0$  and  $n(r) = 0$  for all  $r$ . Hence the left-hand expression in (2.3) is infinite.

Further, let us consider an example of a function which possesses poles. Take for instance  $f(z) = \Gamma(z)$ . It is of order 1 and  $n(r) \sim N(r) \sim r$ ;  $m(r) \sim r \log r$  and so Theorem 1 is not true in this case also.

Further, we have

**Theorem 2.** *Let  $f(z)$  be a meromorphic function of non-integral order  $\rho$  ( $p < \rho < p + 1$ ,  $p$  being any integer) and proximate order  $\rho(r)$ . Then*

$$(2.4) \quad \limsup_{r \rightarrow \infty} \frac{m(r)}{r^{\rho(r)}} \leq \beta [p(\rho - p)^{-1} + (p + 1 - \rho)^{-1} \{p + 1 + 2\rho \cot \frac{1}{2} \pi(\rho - p)\}],$$

where  $\beta$  is defined as

$$\lim_{r \rightarrow \infty} \frac{N(r)}{r^{\rho(r)}} = \beta < \infty.$$

An immediate corollary of this theorem is the following

Corollary 1. For  $p < \varrho < p + 1$ ,

$$(2.5) \quad \limsup_{r \rightarrow \infty} \frac{m(r)}{N(r)} \leq p(\varrho - p)^{-1} + (p + 1 - \varrho)^{-1}[p + 1 + 2\varrho \cot \frac{1}{2}\pi(\varrho - p)].$$

The corollary follows immediately, by using Theorem 2, since

$$\limsup_{r \rightarrow \infty} \frac{m(r)}{r^p N_p(r)} = \limsup_{r \rightarrow \infty} \frac{m(r)r^{\varrho(r)}}{r^p N_p(r)/r^{\varrho(r)}} = \beta^{-1} \limsup_{r \rightarrow \infty} \frac{m(r)}{r^{\varrho(r)}}.$$

However, if we replace  $N(r)$  by  $r^p N_p(r)$  in Theorem 2, we have

Theorem 3. Under the hypothesis of Theorem 2, we have

$$(2.6) \quad \limsup_{r \rightarrow \infty} \frac{m(r)}{r^{\varrho(r)}} \leq \beta^*(p + 1 - \varrho)^{-1}[1 + 2(\varrho - p) \cot \frac{1}{2}\pi(\varrho - p)],$$

where  $\beta^*$  is defined as

$$\lim_{r \rightarrow \infty} \frac{r^p N_p(r)}{r^{\varrho(r)}} = \beta^* < \infty.$$

Corollary 2. For  $p < \varrho < p + 1$ ,

$$(2.7) \quad \limsup_{r \rightarrow \infty} \frac{m(r)}{r^p N_p(r)} \leq (p + 1 - \varrho)^{-1}[1 + 2(\varrho - p) \cot \frac{1}{2}\pi(\varrho - p)].$$

Remark 1. For functions of order  $\varrho$  ( $0 < \varrho < 1$ ) i.e. for which  $p = 0$ , the results in Theorems 2 and 3, and consequently their respective corollaries are identical.

Next, we have a striking deduction from Corollary 1 as follows

Corollary 3. For  $p < \varrho < p + 1$

$$(2.8) \quad \limsup_{r \rightarrow \infty} \frac{m(r)}{u(r) \log r} \leq \varrho A(\varrho),$$

where  $A(\varrho)$  is given by (2.2).

Remark 2. The inequalities in (2.5), (2.7) and (2.8) cannot be removed.

Consider, for instance, (see [2], p. 100) the function

$$f(z) = \prod_{n=1}^{\infty} \left( 1 + \frac{z}{n^2} \right).$$

Then  $m(r) = 2r^{\frac{1}{2}}$ ,  $n(r) \sim r^{\frac{1}{2}}$ ,  $N(r) \sim 2r^{\frac{1}{2}}$ ,  $\rho = 1/2$ .

Finally, we separate meromorphic functions of non-integral order into two classes. According to Nevanlinna [5], a meromorphic function  $f(z)$  of positive non-integral order  $\rho$  is of convergence or divergence class according as

$$(2.9) \quad \int_0^{\infty} r^{-\rho-1} n(r) \, dr$$

converges or diverges.

Now, we have

**Theorem 4.** *The meromorphic function of non-integral order  $\rho$  is of convergence or divergence class according as*

$$(2.10) \quad \int_0^{\infty} r^{-\rho-1} m(r) \, dr$$

converges or diverges.

In the proofs of our theorems we shall very much rely on the following result due to Kamthan ([4], p. 40), which is in fact based on an estimate of  $m(r)$  obtained earlier by Edrei and Fuchs ([1], p. 300).

**Lemma A [4].** *Let  $f(z)$  be a meromorphic function of non-integral order  $\rho$  and let  $p$  be an integer,  $p < \rho < p + 1$ . Then*

$$(2.11) \quad m(r) \leq r^p \int_0^r x^{-p-1} n(x) \, dx + r^{p+1} \int_r^{\infty} x^{-p-2} n(x) \, dx + \\ + \frac{4}{\pi} \sum_{m=0}^{\infty} (2m+1)^{-1} \left[ r^{p-2m} \int_0^r x^{-p+2m-1} n(x) \, dx \right. \\ \left. + r^{p+2m+2} \int_r^{\infty} x^{-p-2m-3} n(x) \, dx \right] + O(r^p).$$

### 3. - Proof of Theorem 1.

We have to consider two cases according as  $f(z)$  is of convergence class or not. In either case  $p < \rho < p + 1$  and  $\int_0^\infty x^{-\alpha} n(x) dx$  converges for  $\alpha > \rho + 1$  and diverges for  $\alpha < \rho + 1$ .

It is sufficient to prove that it is impossible to have

$$(3.1) \quad n(r) \leq \varepsilon m(r), \quad r > r_0(\varepsilon), \quad \varepsilon > 0.$$

Choose  $\alpha$  with  $\rho + 1 \leq \alpha < p + 2$  and such that  $\int_0^\infty x^{-\alpha} n(x) dx$  converges (it converges for  $\alpha > \rho + 1$  in both cases).

Multiplying (3.1) by  $r^{-\alpha}$ , integrating over  $(R, \infty)$  and changing the order of integration in the resulting integrated integrals, we get

$$(3.2) \quad \int_R^\infty r^{-\alpha} n(r) dr \leq \varepsilon \int_R^\infty r^{p-\alpha} dr \int_0^r x^{-p-1} n(x) dx + \\ + \varepsilon \int_R^\infty r^{p-\alpha+1} dr \int_r^\infty x^{-p-2} n(x) dx + \\ + \frac{4}{\pi} \varepsilon \sum_{m=0}^\infty (2m+1)^{-1} \left[ \int_R^\infty r^{p-2m-\alpha} dr \int_0^r x^{-p+2m-1} n(x) dx + \right. \\ \left. + \int_R^\infty r^{p+2m+2-\alpha} dr \int_r^\infty x^{-p-2m-3} n(x) dx \right] + O\left(\int_R^\infty r^{p-\alpha} dr\right),$$

$$(3.3) \quad \int_R^\infty r^{-\alpha} n(r) dr \leq \varepsilon I_1 + \varepsilon I_2 + \frac{4\varepsilon}{\pi} \sum_{m=0}^\infty (2m+1)^{-1} (I_3 + I_4) + I_5 \quad (\text{say}).$$

Now by changing the order of integration in (3.2), we notice that

$$I_1 = \int_0^R x^{-p-1} n(x) dx \int_R^\infty r^{p-\alpha} dr + \int_R^\infty x^{-p-1} n(x) dx \int_x^\infty r^{p-\alpha} dr \\ = (\alpha - p - 1)^{-1} R^{p+1-\alpha} \int_0^R x^{-p-1} n(x) dx + (\alpha - p - 1)^{-1} \int_R^\infty x^{-\alpha} n(x) dx;$$

$$I_2 = \int_R^\infty x^{-p-2} n(x) dx \int_R^\infty r^{p+1-\alpha} dr \leq (p+2-\alpha)^{-1} \int_R^\infty x^{-\alpha} n(x) dx;$$

$$\begin{aligned}
I_3 &= \int_0^R x^{-p+2m-1} n(x) dx \int_R^\infty r^{p-2m-\alpha} dr + \int_R^\infty x^{-p+2m-1} n(x) dx \int_R^\infty r^{p-2m-\alpha} dr \\
&\leq (2m-p-1+\alpha)^{-1} R^{p-\alpha+1} \int_0^R x^{-p-1} n(x) dx + (2m-p-1+\alpha)^{-1} \int_R^\infty x^{-\alpha} n(x) dx; \\
I_4 &= \int_R^\infty x^{-p-2m-3} n(x) dx \int_R^\infty r^{p+2m+2-\alpha} dr \leq (2m+p+3-\alpha)^{-1} \int_R^\infty x^{-\alpha} n(x) dx; \\
I_5 &\leq O(R^{p+1-\alpha}).
\end{aligned}$$

Therefore, (3.3) implies that

$$\begin{aligned}
(3.4) \quad \int_R^\infty r^{-\alpha} n(r) dr &\leq \varepsilon A(\alpha, p) \int_R^\infty x^{-\alpha} n(x) dx + \\
&\quad + \varepsilon B(\alpha, p) R^{p+1-\alpha} \int_0^R x^{-p-1} n(x) dx + O(R^{p+1-\alpha}),
\end{aligned}$$

where

$$\begin{aligned}
A(\alpha, p) &= (\alpha-p-1)^{-1} + (p+2-\alpha)^{-1} + \frac{4}{\pi} \sum_{m=0}^{\infty} (2m+1)^{-1} \times \\
&\quad \times \left[ \frac{1}{2m-p-1+\alpha} + \frac{1}{2m+p-\alpha+3} \right],
\end{aligned}$$

and

$$B(\alpha, p) = (\alpha-p-1)^{-1} + \frac{4}{\pi} \sum_{m=0}^{\infty} \frac{1}{(2m+1)(2m-p-1+\alpha)}.$$

It is easily seen that  $A(\alpha, p) < \infty$  and  $B(\alpha, p) < \infty$ . Therefore, by choosing  $\varepsilon < 1/2A(\alpha, p)$  and collecting the terms in (3.4), we get

$$(3.5) \quad \frac{1}{2} \int_R^\infty r^{-\alpha} n(r) dr \leq \varepsilon B(\alpha, p) R^{p+1-\alpha} \int_1^R x^{-p-1} n(x) dx + O(R^{p+1-\alpha}).$$

In case  $f(z)$  is of divergence class (holding  $R$  fixed), let  $\alpha \rightarrow \rho + 1$ , the left-hand side of (3.5) becomes infinite, while its right hand side approaches a finite limit. So (3.1) leads to a contradiction.

In case  $f(z)$  is of convergence class, we may take  $\alpha = \rho + 1$ , since  $n(r)$  increases, (3.5) implies

$$\frac{1}{2}n(R)\varrho^{-1}R^{-\varrho} \leq \varepsilon R^{p-\varrho} \left[ \left\{ (\varrho - p)^{-1} + \frac{4}{\pi} \sum_{m=0}^{\infty} \frac{1}{(2m+1)(2m-p+\varrho)} \right\} \times \right. \\ \left. \times \int_1^R x^{-p-1}n(x) dx \right] + O(R^{p-\varrho}),$$

and since this holds for large enough  $R$ , for every positive  $\varepsilon$ , we have

$$n(r) = o\left[r^p \int_1^r x^{-p-1}n(x) dx\right].$$

Since  $\int_1^{\infty} r^{-p-\alpha}n(r) dr$  diverges for  $1 < \alpha < \varrho - p + 1$ , for such  $\alpha$ , we have as  $R \rightarrow \infty$

$$\int_1^R r^{-p-\alpha}n(r) dr = O\left[\int_1^R r^{-\alpha} dr \int_1^r x^{-p-1}n(x) dx\right] \\ = O\left[\int_1^R x^{-p-1}n(x) dx \int_x^R r^{-\alpha} dr\right] = O\left[\int_1^R x^{-p-\alpha}n(x) dx\right],$$

a contradiction. Hence (2.3) follows.

#### 4. - Proof of Theorem 2.

Since  $n(x) dx = x dN(x)$  almost everywhere in  $[0, x]$ , the result in the Lemma A may be rewritten as

$$(4.1) \quad m(r) \leq pr^p \int_0^r x^{-p-1}N(x) dx + (p+1)r^{p+1} \int_0^{\infty} x^{-p-2}N(x) dx \\ + \frac{4}{\pi} \sum_{m=0}^{\infty} (2m+1)^{-1} \left[ (p-2m)r^{p-2m} \int_0^r x^{2m-p-1}N(x) dx \right. \\ \left. + (2m+p+2)r^{2m+p+2} \int_r^{\infty} x^{-2m-p-3}N(x) dx \right] + O(r^p) \\ = I_6 + I_7 + \frac{4}{\pi} \sum_{m=0}^{\infty} (2m+1)^{-1} [I_8 + I_9] + O(r^p) \quad (\text{say}).$$

From the hypothesis, we have  $\beta - \varepsilon < N(r)/r^{\varrho(r)} < \beta + \varepsilon$  for  $r > r_0 = r_0(\varepsilon)$ ,  $\varepsilon > 0$ . Therefore

$$I_6 \leq (\beta + \varepsilon) p r^p \int_{r_0}^r x^{\varrho(x)-p-1} dx + O(r^p) \sim (\beta + \varepsilon) p (\varrho - p)^{-1} r^{\varrho(r)} + O(r^p),$$

and

$$I_7 \leq (\beta + \varepsilon) (p + 1) r^{p+1} \int_p^{\infty} x^{\varrho(x)-p-2} dx \sim (\beta + \varepsilon) (p + 1) (p + 1 - \varrho)^{-1} r^{\varrho(r)}.$$

Also for  $m < p/2$

$$\begin{aligned} I_8 &\leq (\beta + \varepsilon) (p - 2m) r^{p-2m} \int_{r_0}^r x^{\varrho(x)-p+2m-1} dx + O(r^{p-2m}) \sim \\ &\sim (\beta + \varepsilon) (p - 2m) (\varrho - p + 2m)^{-1} r^{\varrho(r)} + O(r^{p-2m}), \end{aligned}$$

and for  $m \geq p/2$

$$\begin{aligned} I_8 &\leq -(\beta - \varepsilon) (2m - p) r^{p-2m} \int_{r_0}^r x^{\varrho(x)-p+2m-1} dx + O(r^{p-2m}) \sim \\ &\sim -(\beta - \varepsilon) (2m - p) (\varrho - p + 2m)^{-1} r^{\varrho(r)} + O(r^{p-2m}). \end{aligned}$$

Furthermore for all  $m \geq 0$

$$\begin{aligned} I_9 &\leq (\beta + \varepsilon) (p + 2m + 2) r^{p+2m+2} \int_p^{\infty} x^{\varrho(x)-p-2m-3} dx \sim \\ &\sim (\beta + \varepsilon) (p + 2m + 2) (p + 2m + 2 - \varrho)^{-1} r^{\varrho(r)}. \end{aligned}$$

Hence for  $m < p/2$

$$\begin{aligned} I_8 + I_9 &\leq (\beta + \varepsilon) [(p - 2m) (\varrho - p + 2m)^{-1} + \\ &+ (p + 2m + 2) (p + 2m + 2 - \varrho)^{-1}] r^{\varrho(r)} + O(r^{p-2m}), \end{aligned}$$

whereas for  $m \geq p/2$

$$\begin{aligned} I_8 + I_9 &\leq -(\beta - \varepsilon) (2m - p) (\varrho - p + 2m)^{-1} r^{\varrho(r)} + \\ &+ (\beta + \varepsilon) (p + 2m + 2) (p + 2m - 2\varrho)^{-1} r^{\varrho(r)} + O(r^{p-2m}). \end{aligned}$$



Using the above estimates (4.1) gives

$$\begin{aligned} \frac{m(r)}{r^{\varrho(r)}} &\leq (\beta + \varepsilon)p(\varrho - p)^{-1} + (\beta + \varepsilon)(p + 1)(p + 1 - \varrho)^{-1} + \\ &+ \frac{4}{\pi} \sum_{m < p/2} (2m + 1)^{-1} [(\beta + \varepsilon)(p - 2m)(\varrho - p + 2m)^{-1} + \\ &+ (\beta + \varepsilon)(p + 2m + 2)(p + 2m + 2 - \varrho)^{-1} + O(r^{p-2m})] + \\ &+ \frac{4}{\pi} \sum_{m \geq p/2} (2m + 1)^{-1} [(\beta + \varepsilon)(p + 2m + 2)(p + 2m + 2 - \varrho)^{-1} - \\ &- (\beta - \varepsilon)(2m - p)(\varrho - p + 2m)^{-1} + O(r^{p-2m})] + O(r^{p-\varrho(r)}) \quad (r \geq r_0), \end{aligned}$$

which implies

$$\begin{aligned} \limsup_{r \rightarrow \infty} \frac{m(r)}{r^{\varrho(r)}} &\leq \beta \left[ p(\varrho - p)^{-1} + (p + 1)(p + 1 - \varrho)^{-1} + \right. \\ &\quad \left. + \frac{8\varrho}{\pi} \sum_{m=0}^{\infty} \frac{1}{(2m + \varrho - p)(2m + p + 2 - \varrho)} \right] \\ &= \beta \left[ p(\varrho - p)^{-1} + (p + 1)(p + 1 - \varrho)^{-1} + \frac{2\varrho}{\pi} (p + 1 - \varrho)^{-1} \right. \\ &\quad \left. \times \sum_{m=0}^{\infty} \left\{ \frac{1}{m + (\varrho - p)/2} \frac{1}{(m + 1) - (\varrho - p)/2} \right\} \right] \\ &= \beta [p(\varrho - p)^{-1} + (p + 1 - \varrho)^{-1} \{p + 1 + 2\varrho \cot \frac{1}{2} \pi(\varrho - p)\}]. \end{aligned}$$

Hence the theorem is established.

### 5. - Proof of Theorem 3.

From the definition of  $N_p(r)$ , we note that  $n(x)dx = x^{p+1}dN_p(x)$ , almost everywhere in  $[0, x]$ . Now using the arguments of Kamthan (see [4], p. 38)

the Lemma A gives

$$\begin{aligned}
 m(r) &\leq r^{p+1} \int_r^\infty x^{-2} N_p(x) dx + \frac{4}{\pi} \sum_{m=0}^\infty (2m+1)^{-1} \times \\
 &\quad \times \left[ -2mr^{p-2m} \int_0^r x^{2m-1} N_p(x) dx + \right. \\
 &\quad \left. + (2m+2)r^{p+2m+2} \int_r^\infty x^{-2m-3} N_p(x) dx \right] + O(r^p), \\
 (5.1) \quad m(r) &= I_{10} + \frac{4}{\pi} \sum_{m=0}^\infty (2m+1)^{-1} [I_{11} + I_{12}] + O(r^p) \quad (\text{say}) .
 \end{aligned}$$

From the hypothesis, we have

$$\beta^* - \varepsilon < \frac{r^p N_p(r)}{r^{\varrho(r)}} < \beta^* + \varepsilon \quad (r > r_0(\varepsilon), \varepsilon > 0) .$$

Now computing along the lines of Theorem 2, we have

$$\begin{aligned}
 I_{10} &\leq (\beta^* + \varepsilon)(p+1-\varrho)^{-1} r^{\varrho(r)}, \\
 I_{11} &\leq O(r^{p-2m}) - 2m(\beta^* - \varepsilon)(\varrho - p + 2m)^{-1} r^{\varrho(r)}, \\
 I_{12} &\leq (\beta^* + \varepsilon)(2m+2)(p+2m+2-\varrho)^{-1} r^{\varrho(r)},
 \end{aligned}$$

and hence the theorem follows.

#### 6. - Proof of Theorem 4.

To prove this, it is enough to show that convergence of

$$\int_0^\infty r^{-\varrho-1} n(r) dr \Leftrightarrow \text{convergence of } \int_0^\infty r^{-\varrho-1} J_k(r) dr ,$$

where  $J_k(r)$ , ( $k = 1, 2, 3, 4, 5$ ) stands for the  $k$ th term in the right hand expression in (2.11). Clearly

$$\int_0^\infty r^{-\varrho-1} J_1(r) dr = \int_0^\infty x^{-p-1} n(x) dx \int_x^\infty r^{-\varrho+p-1} dr = (\varrho - p)^{-1} \int_0^\infty x^{-\varrho-1} n(x) dx ,$$

and

$$\begin{aligned} \int_R^\infty r^{-\varrho-1} J_2(r) dr &= \int_R^\infty x^{-p-2} n(x) dx \int_R^\infty r^{p-\varrho} dr \\ &= (p+1-\varrho)^{-1} \left[ \int_R^\infty x^{-\varrho-1} n(x) dx - R^{p+1-\varrho} \int_R^\infty x^{-p-2} n(x) dx \right]. \end{aligned}$$

Therefore, (6.1) implies

$$\begin{aligned} (1 - R^{p+1-\varrho})(p+1-\varrho)^{-1} \int_R^\infty x^{-\varrho-1} n(x) dx &< \\ &< \int_R^\infty r^{-\varrho-1} J_2(r) dr < (p+1-\varrho)^{-1} \int_R^\infty x^{-\varrho-1} n(x) dx, \end{aligned}$$

since  $\varrho+1 < p+2$ . Also, we have

$$\begin{aligned} \int_0^\infty r^{-\varrho-1} J_3(r) dr &= \frac{4}{\pi} \sum_{m=0}^\infty (2m+1)^{-1} \int_0^\infty x^{-p+2m-1} n(x) dx \int_x^\infty r^{p-\varrho-2m-1} dr \\ &= S_1 \int_0^\infty x^{-\varrho-1} n(x) dx \end{aligned}$$

and

$$\begin{aligned} \int_R^\infty r^{-\varrho-1} J_4(r) dr &= \frac{4}{\pi} \sum_{m=0}^\infty (2m+1)^{-1} \int_R^\infty x^{-p-2m-3} n(x) dx \int_R^x r^{p-\varrho+2m+1} dr, \\ (6.2) \quad \int_R^\infty r^{-\varrho-1} J_4(r) dr &= \frac{4}{\pi} \sum_{m=0}^\infty (2m+1)^{-1} (2m+p-\varrho+2)^{-1} \times \\ &\quad \times \left[ \int_R^\infty x^{-\varrho-1} n(x) dx - R^{2m+p-\varrho+2} \int_R^\infty x^{-2m-p-3} n(x) dx \right], \end{aligned}$$

where

$$S_1 = \frac{4}{\pi} \sum_{m=0}^\infty \frac{1}{(2m+1)(2m+\varrho-p)}.$$

It is easily seen, from (6.2), that

$$S_2 \int_R^\infty x^{-\varrho-1} n(x) dx < \int_R^\infty r^{-\varrho-1} J_4(r) dr < S_3 \int_R^\infty x^{-\varrho-1} n(x) dx,$$

where

$$S_2 = \sum_{m=0}^{\infty} \frac{1 - R^{2m+p-\varrho+2}}{(2m+1)(2m+p-\varrho+2)}, \quad S_3 = \sum_{m=0}^{\infty} \frac{1}{(2m+1)(2m+p-\varrho+2)}.$$

Also,

$$\int_R^{\infty} r^{-\varrho-1} J_5(r) \, dt = O(R^{p-\varrho}).$$

This completes the proof of Theorem 4, since  $p < \varrho < p + 1$ , and  $S_1, S_2, S_3$  are convergent series.

#### A b s t r a c t .

*Certain growth relations of the Nevanlinna proximity function  $m(r)$  of a meromorphic function  $f(z)$  of non-integral order  $\varrho$ , relative to  $N(r)$ ,  $N_p(r)$ ,  $n(r)$  and  $re^{(\varrho)}$  ( $\varrho(r)$  being a proximate order of  $f(z)$ ), have been considered. It has been observed, by means of examples, that these results are not necessarily true for meromorphic functions of integral order. Also, it has been shown that a meromorphic function of non-integral order  $\varrho$  is of convergence or divergence class according as*

$$\int r^{-\varrho-1} m(r) \, dr$$

*converges or diverges.*
